It is with this backdrop that new manufacturer entrants into the Canadian marketplace that do not share this same sense of commitment are quickly identified as a threat to the continued diligence of incumbent members.

This association wishes to alert the design community and building departments in all parts of the Canadian construction marketplace of new entrants into the EIFS marketplace and the potential for inadequate or non-existent acceptances and/or approvals.

While recognizing that competition is a healthy element of free enterprise, disregard for the most

basic elements of EIFS promotion and compliance serves only to weaken our industry as a whole.

New manufacturer entrants into the Canadian EIFS market place, and those EIFS contractors that wish to support their product offering, should take note of the following:

- Valid CCMC (Canadian Construction Materials Center) Report, providing assurance of compliance with the intent of the national building code and Ontario Ministry of Municipal Affairs and Housing Ruling, authorizing use of specific EIFS products in Ontario.
- Valid fire listings generated by a Standards Council Canada of Certification accredited Organization, i.e. Underwriters Laboratories of Canada or Intertek ETL Semko thereby confirming performance fire in conditions as evaluated against CAN / ULC S101 & S134.
- Vigilant control and insistence on all components of the EIFS assembly being supplied by the same manufacturer.
